EXECUTIVE MESSAGE

Greetings friends and supporters,

Since our start in 1967, Legal Aid's focus has been on representing thousands of low-income Arkansans annually. As we matured, we learned that we have to be more mindful, deliberate, and thoughtful when determining how we use our limited resources. The world simply does not give us what we need to assist everyone at the level that would benefit them most. We have extended our work beyond individual client representation to include systemic advocacy and extensive community engagement.

Rising consumer costs made 2022 a difficult year for many Arkansans living on the edge as they struggled to make ends meet. They came to us for help in near-record numbers, and we were up to the challenge.

While I can't speak to all the great work we did, each of our practice groups made significant contributions. It all starts with intake workers, the public face of legal aid. This core of dedicated staff processed more than 8,000 clients with empathy and kindness, making their outlook turn from despair to hope.

Our practice groups worked diligently to assure due process prior to termination of health care benefits, provide protection for more almost 2,000 survivors of domestic violence, address egregious Fair Housing violations, and prevent unfair debt collection practices. We had a focus on assisting clients and families impacted by substance use disorder, which has become a national model for replication.

The efforts of our staff, board, and volunteers were centered on making a difference in the lives of our clients, and when appropriate, being agents of large-scale change.

Through it all, the clients inspired our work with their courage and determination. They are our raison d'etre.



OUR PROGRAMS

ADVOCACY REPORT

Litigation is the core of what we do at Legal Aid of Arkansas. To be sure, community outreach, engagement, and advocacy are all important components of our work. They are vital to our mission as we work to fight poverty, maintain dignity, and assure justice. While we do these things well, others in the community are also engaged in this work.

We are unique in providing attorney representation to clients. Other than some nuanced and focused exceptions, we are the only game in town. While we can agree that the most humble among us should be the peer of the most affluent when accessing justice, many low-income Arkansans would be left standing outside the courthouse door if not for Legal Aid.

The number of people that have only us to turn to with civil legal problems is staggering. While focusing on people below 125%, we can generally find a way to help those with household income in up to 200% of poverty. That is 37.8% of everyone living in the area we serve or 450,823 people. For every attorney we have, we have a minimum of 15,000 potential clients, and the 2022 LSC Justice Gap Study tells us that 3 in 4 of those people experienced at least one civil legal problem in the past year. To help every person with a problem, our attorneys would have to help over 11,000 clients each. The most dedicated attorney might be able to help 3% of that number and still maintain some degree of professional responsibility. We swim upstream, but we do so with intentionality.


We are one of 22 programs funded by the Legal Services Corporation in nine Southern states. Dividing the number of clients served by the eligible poverty population, we finished well ahead of all but one of these programs in cases closed per eligible client, and our numbers were more than double those of 15 of the other programs. We generally do a lot more with less.

In 2022 litigation led us to virtually every possible level of court in the country. We had cases at the United States Supreme Court, 8th Circuit Court of Appeals, both Arkansas Federal District Courts, U.S. Tax and Bankruptcy Court, the Arkansas Supreme Court and Court of Appeals, and every Circuit Court where we practice, as well as significant litigation on the administrative and state district court level.

We are a firm focused on litigation that alleviates suffering and poverty. We are a firm that provides hope. We are Legal Aid of Arkansas.

DOMESTIC JUSTICE

The Domestic Justice workgroup helps with a variety of family law issues, including divorces, protective orders, and child custody cases in which there is an immediate or ongoing risk of harm. We also assist in other areas including, but not limited to, guardianships for adults and minors, problems with birth certificates, child support issues, emancipation, and name changes.

HOUSING

The Housing workgroup fights housing-related discrimination under various federal, state, and local laws. We help people resolve private landlord-tenant issues, defend tenants facing civil eviction suits, and aid homeowners facing foreclosure suits. As COVID unwinds and housing prices across Arkansas soar, we are working hard to ensure all Arkansans can attain, or maintain safe, affordable housing.

ECONOMIC JUSTICE

The Economic Justice workgroup helps with a wide range of civil legal issues, including access to public benefits (including Social Security, Medicaid, unemployment, and SNAP benefits), employment discrimination (including Title VII, ADEA, ADA, and PDA), and education law issues (including ADA, IDEA, 504, FAPE, and LRE). A primary goal of the Economic Justice workgroup is insuring access to healthcare for low-income Arkansans. As pandemic-era protections begin to unwind, the workgroup expects to help as an unprecedented number of Medicaid beneficiaries faced with issues relating to eligibility or reductions in services received. The workgroup's advocacy involves litigation at all levels of both state and federal courts in Arkansas.

CONSUMER PROTECTION

The Consumer Protection workgroup focuses on asset, income, and resource protection. It protects consumers from unfair trade and debt collection practices. In 2022 the Consumer Protection workgroup expanded its re-entry area of practice to include assisting clients with early discharge of their state supervised probation/parole. In addition to sealing criminal records, this helped remove barriers to employment and housing. The workgroup also continued its fight against unfair trade and abusive debt collection practices.

OUR PROJECTS

BEYOND OPIOIDS PROJECT

Beyond Opioids provides free civil legal services to eligible clients impacted by the **opioid crisis** and other substance use disorders in Arkansas.

The Beyond Opioids Project is a consortium of **prevention**, **treatment**, **and recovery service providers** led by the two legal aid programs in Arkansas: the Center for Arkansas Legal Services (CALS) and Legal Aid of Arkansas (Legal Aid).

In 2022, the Beyond Opioids Project closed 615 cases, serving 1,566 people impacted by Opioid Use Disorder or Substance Use Disorder. Of the cases served in 2022, 66% were focused on domestic justice.

LOW-INCOME TAXPAYER CLINIC

The Low Income Taxpayer Clinic ensures the fairness and integrity of the tax system for taxpayers who are low-income or speak English as a second language.

They provide representation, resources, and education on rights. The LITC team works in tandem with the IRS Taxpayer Advocate Service and provides services at Volunteer Income Tax Assistance sites. The program actively advocates and identifies issues that may be unjustly facing low-income Arkansans within the IRS tax system.

In 2022, clinic advocates helped clients **recover over \$565,000 for 90 clients** against the IRS. The LITC team **conducted 29 educational activities** and **participated in 59 outreach events** in English, Spanish, and Marshallese.

OUR PROJECTS

FAIR HOUSING PROJECT

The Fair Housing Project of Legal Aid of Arkansas works to **eliminate housing discrimination** and to ensure **equal housing opportunities for all** people through education, outreach, public policy initiatives, advocacy, and enforcement.

In 2022, the Fair Housing Project closed 151 cases, serving 315 people impacted by housing discrimination, and provided representation in state or federal courts on 24 cases. Our housing team and our testers in the community conducted 92 fair housing tests.

MEDICAL-LEGAL PARTNERSHIPS (MLP)







Legal Aid of Arkansas is engaged in Medical-Legal Partnerships (MLP) throughout the state with a variety of healthcare providers.

MLP's team lawyers and paralegals work with healthcare teams in medical settings to detect, address and prevent health-harming social conditions for people. The goal is for attorneys and medical staff to work together to achieve lasting positive health outcomes.

In 2022, the MLP team **closed 241 cases referred** by Arkansas Children's Hospital and Mid-Delta Health Systems.

ADVERSE CHILDHOOD EXPERIENCES (ACES)



Legal Aid of Arkansas works to mitigate Adverse Childhood Experiences (ACES) by (ACES) for households with children.

By prioritizing cases where there is a child under the age of 5, advocates help prevent stress in a child's life from causing serious physical, mental, and emotional issues. The goal is to work with community providers to achieve positive outcomes.

In 2022, Legal Aid advocates **served 1,686 households** with children under the age of 5 years old.

SUCCESS STORIES

CLIENT CASE

Ms. Peacock* already had an Order of Protection, but her divorce was not going well. She and her husband could not agree on how to fairly divide the marital property, so the two issues were bifurcated (i.e., the divorce was granted but they needed to move forward with separating the property in separate court actions). Ms. Peacock knew she needed an attorney's help with this matter.

Ms. Peacock had been a mom – working low-pay jobs so she could make caring for her family and supporting her husband's employment her first priority. Now that their relationship was over, Mr. Peacock did not think he needed to share the significant work-related assets of their marriage. He had a plan that would allow him to keep all of his retirement while also walking away debt-free. He offered to give his ex-wife \$10,000 but insisted she takes on all of the marital debt – and that would settle the case.

Unaware of her legal rights, Ms. Peacock was elated with this offer. However, her Legal Aid attorney urged her to wait until after Discovery to make any decisions. Ms. Peacock agreed, and Discovery revealed her ex-husband's 401K plan was worth \$128,000. Her attorney advised her that, under the Qualified Domestic Relations rules, she was legally entitled to half of the retirement. Instead of receiving \$10,000 along with an additional debt burden, Ms. Peacock was awarded \$64,000 and her ex-husband was ordered to pay all of the marital debts. Instead of facing poverty and homelessness, Ms. Peacock was able to purchase a modest home and move forward from a better place.

PRO BONO IMPACT

HIGHLIGHT 2022: IN-PERSON CLINIC WORK

2022 saw the easing of COVID restrictions, allowing us to get back to in-person events, including Clinics, Helpdesks, and Community Education Events.

In 2022, we held our annual Single Parent Scholarship Fund Estate Planning Clinic in Benton County, Equality Crew Estate Planning Clinic in NWA, several Name Change Clinics in NWA, Constitution Day Record Sealing Clinic in Mississippi County, and two Estate Planning Clinics with EAAAA and the VA in Jonesboro, in person.

The clinic setting allows us to make a big impact in a short period. We can assist with an individual's legal need, start to finish, in one day. At clinics held from July 2022 to November 2022, volunteers assisted 174 clients, prepared 371 documents, and provided advice and extended services to several more.

2022 also allowed us to get back to holding in-person helpdesks, including a week-long Helpdesk in Washington County to celebrate Pro Bono Week, which was staffed fully with volunteer attorneys and students.

We also held several information sessions in the community to educate members on their rights and the law, including Record Sealing and Estate Planning.

Getting out, in person, into the community is when we make the biggest and best impacts.

PRO BONO IMPACT



On Constitution Day, law students from the University of Arkansas, Mississippi County Prosecutors, Court Clerks, and Judges volunteered to seal criminal records for 50 clients, prepared 150 legal documents, and provided advice for 30 individuals.



During Pro Bono week, University of Arkansas law students learn about Pro Bono opportunities at Legal Aid of Arkansas.



Legal Aid of Arkansas partnered with the University of Arkansas School of Law, Cocoon Collective, The Transition Closet, QLaw, OutLaw, and Arkansas Appleseed Legal Justice Center to host a Name and Gender marker change clinic, successfully assisting 20 clients with 80 documents.



Legal Aid of Arkansas hosted an Estate Planning Clinic with East Arkansas Area Agency on Aging in Jonesboro, preparing over 30 estate planning documents and advising several individuals. Pro Bono attorneys accepted two clients for extended services.



The University of Arkansas students volunteered at the Washington County Help Desk during Pro Bono Week.



Legal Aid staff helped prepare 167 documents for 58 clients during the Estate Planning and Gender and Marker Change Clinic at the Heroncrest event center in Elm Springs, AR.

COMMUNITY ENGAGEMENT

Now that Covid 19 is (mostly) behind us, Legal Aid is excited to more deeply engage with our community. Throughout the pandemic, we continued to stay in touch via Zoom and Facebook and we are happy to say that, by the end of December 2022, we were able to reopen clinics and start to meet with people in person. We love providing free legal services and educational outreach to our community, as well as getting the chance to collaborate with other organizations to ensure justice is available to everyone.






