VITA (Volunteer Income Tax Assistance): trained & certified volunteers provide free tax preparation services to individuals with low to moderate incomes, as well as persons with disabilities.

TCE (Tax Counseling for the Elderly): trained & certified volunteers, specifically trained in issues relevant to seniors, provide free tax preparation to seniors and low income taxpayers.

AARP Tax-Aide: trained & certified volunteers in partnership with AARP provide free tax preparation to low income taxpayers and taxpayers aged 50 and older, regardless of income.

FSA (facilitated self-assistance): trained and certified volunteers supervise taxpayer self-preparation.
