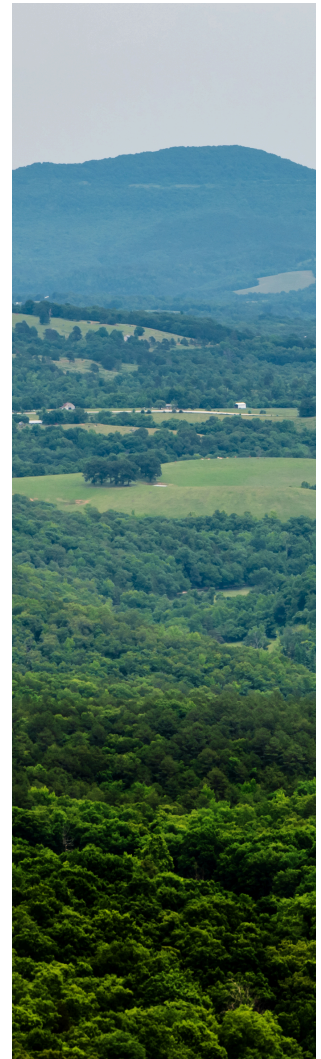
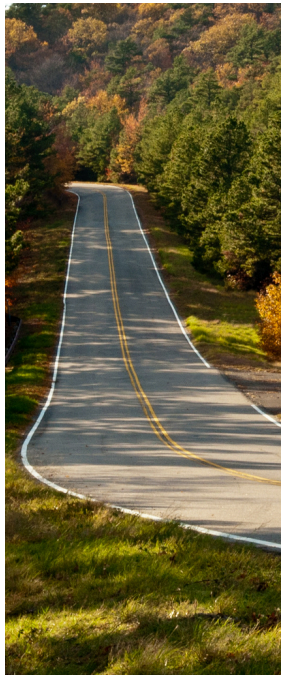
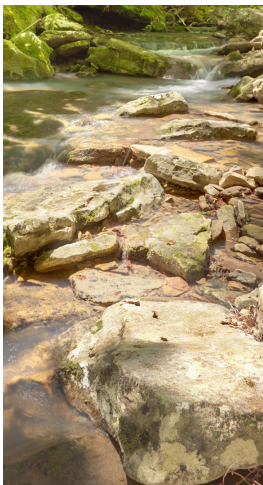

DEAR FRIENDS,

2025 was a year of transition for civil legal aid in Arkansas.

After extensive study and recommendations by the Arkansas Legal Aid Task Force in 2024, the state moved toward a unified vision for delivering free civil legal assistance—one that emphasizes consistency, efficiency, and statewide access.

As the year ended, the Center for Arkansas Legal Services, founded in 1965 and long a bastion of service for Arkansans in Central and South Arkansas, ceased operations. **Legal Aid of Arkansas is both honored and humbled to be the primary provider of free legal services to qualified Arkansans statewide starting in 2026.**

This shift was not a merger but a strategic statewide realignment. The transition promises not only seamless continuation of services for existing clients but also significant improvements in clarity, consistency, and accessibility for the public. By eliminating duplicated systems and centralizing service delivery, the unified model is expected to improve efficiency and reduce costs—factors crucial to meeting the growing civil legal needs of Arkansans.

It is important to acknowledge the profound impact of the Center for Arkansas Legal Services decades of service and to honor the commitment of their staff, leadership, and community partners. This annual report documents the work, challenges, and achievements of a year defined by collaboration, careful planning, and a shared commitment to equal access to justice. The groundwork laid during this period ensures that Arkansas enters the next chapter of legal aid delivery stronger, more unified, and better equipped to serve every corner of our state.

At Legal Aid, we will work tirelessly to ensure that the humblest among us have a voice when seeking help to correct a wrong. We will treat those who come to us in a time of need with the utmost dignity and respect. We will demand justice and accept nothing less.

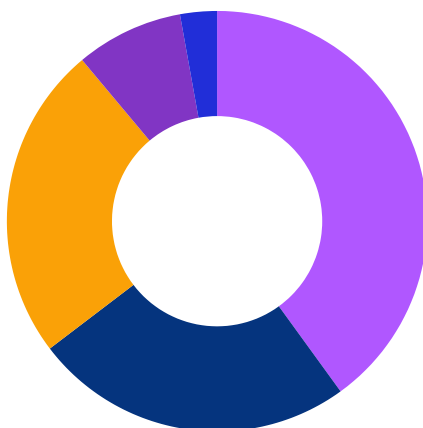

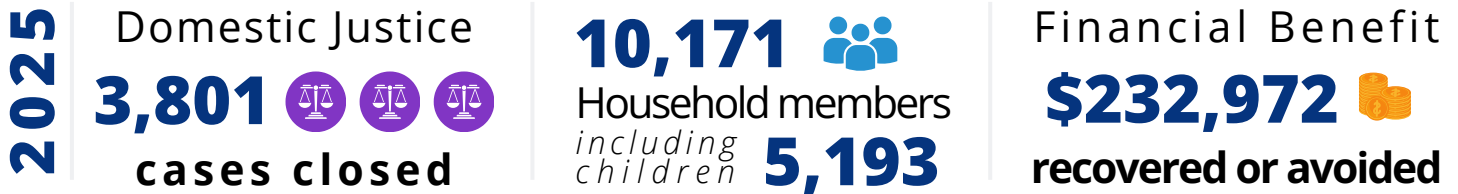

PRACTICE AREA

DOMESTIC JUSTICE

Our Domestic Justice workgroup helps victims of domestic violence, vulnerable children, and families find a pathway to **immediate safety and long-term stability** through comprehensive legal representation, advocacy, and outreach. We focus on mitigating **Adverse Childhood Experiences (ACEs)** and helping families avoid or overcome trauma by providing legal guidance on critical matters, including **Orders of Protection, custody, and guardianship**.



Our Domestic Justice workgroup expanded into new counties and added three new staff members, resulting in a 12% increase in cases closed as we scaled toward statewide service.

Legal Aid helped 924 individuals and families with **Orders of Protection** in 2025. Orders of Protection secure **immediate physical safety**, preventing violence and further harm.

Rhea* believed that all children need their father. However, she didn't know how to protect her young children while their father beat, threatened, demeaned, and socially isolated her. She was often scared and doubted her self-worth. She told her Legal Aid attorney, Kris Ramsfield, "[I don't] know my rights when it comes to all of this or what everything means."

Kris helped her seek an Order of Protection and patiently supported her as she learned her rights and worked through her belief that the violence was her fault. It wasn't a straight path. There were setbacks, fears, and second chances. But with legal support, counseling, and effort, Rhea found a way forward for herself and her children.






Today, she stands confident and independent, building a peaceful life for her young family. Legal help gave her the space to start again.

PRACTICE AREA

CONSUMER PROTECTION

Our Consumer Protection workgroup helps low-income Arkansans achieve **financial security and long-term stability** by providing the legal assistance they need to **safeguard their assets, income, and vital resources**. We defend clients against **predatory debt collectors**, challenge **unfair trade practices**, assist with **bankruptcy filings**, and file petitions to **seal criminal records**. By removing barriers to employment and housing, we ensure equal access to justice and empower individuals to build a better future.

Our Consumer Protection workgroup expanded into new counties and added a new staff member, driving a 31% increase in closed cases as we broaden our advocacy for low-income Arkansans.

Legal Aid addressed **433 collection-related cases** in 2025. Ensuring protection from unlawful garnishments is **vital for the financial stability** of vulnerable Arkansans.

After the recent loss of her son, Donna* placed the proceeds from his life insurance policy into a savings account to help cover funeral expenses and stabilize her finances. Within weeks, she discovered that an old debt collector had filed a Writ of Garnishment, seeking to collect nearly five times the original amount she owed.

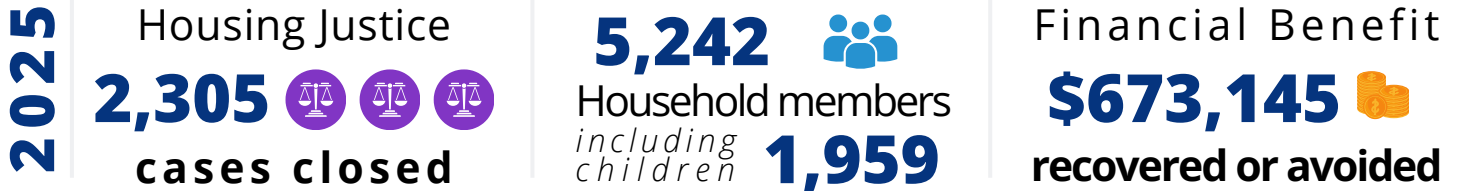
Legal Aid’s Consumer Protection attorney, Josh Eide, successfully filed a Motion to Quash the garnishment because Arkansas law prohibits collection against funds paid under life insurance policies. Access to the resources Donna needed during this difficult time was restored.

PRACTICE AREA

HOUSING JUSTICE

Our Housing Justice workgroup helps low-income Arkansans achieve **housing stability and security** by providing legal representation and education. We **defend tenants facing eviction**, support homeowners at **risk of foreclosure**, and **challenge housing discrimination**. We also assist with critical property matters, including **deeds, land contracts**, and essential **estate planning** such as wills and powers of attorney to **remove barriers to stable housing** and empower families to build a foundation for lasting well-being.



"Our Housing Justice workgroup expanded its reach and legal education into new counties by adding six staff members, resulting in a 39% increase in closed cases.

In 2025, Legal Aid assisted 89 individuals with **Reasonable Accommodation requests**. Securing accommodations is vital for **protecting housing rights** for Arkansans.

SNAPSHOT: CASES SERVED



Charlie*, a disabled Veteran living in public housing, became upset when advised he was behind on his rent due to an increase for which he had never received notice. He emailed the office asking for evidence that his rent had been raised – and they ignored him. He went into the office, was treated dismissively, and a heated conversation ensued.

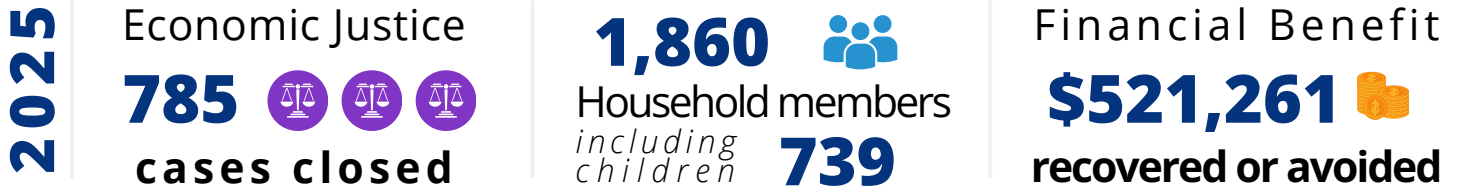
He angrily exited the office and soon thereafter received a Notice to Vacate. He reached out to Legal Aid for help. Attorney Ginny Ashcraft conferred with the client's physician and created a Reasonable Accommodation requiring Charlie to return to therapy and to interact with the Housing Authority remotely. The Reasonable Accommodation was approved, and the Veteran was able to remain in his home.

PRACTICE AREA

ECONOMIC JUSTICE

Our Economic Justice workgroup helps low-income Arkansans achieve **economic security and long-term stability** by providing the legal representation and advocacy they need to access **vital public benefits and healthcare**. We represent clients in state and federal courts on critical matters, including **Social Security, Medicaid, Medicare, and Veterans' benefits**, as well as **unemployment and employment rights**. By **challenging denials of essential disability and educational services**, we **remove systemic barriers** to financial stability and ensure individuals have the resources they need to build a secure future.



Our Economic Justice workgroup onboarded three new staff members and expanded into new counties, scaling our impact and increasing access to vital benefits for low-income Arkansans.

Legal Aid assisted **87 people** with **Medicaid issues** in 2025. Programs like ARChoices are vital for helping **seniors and people with disabilities live independently at home**.

SNAPSHOT: CASES SERVED



This past year, Legal Aid has represented several clients enrolled in ARChoices, a Medicaid program serving older adults and people with physical disabilities. Inadequate patient assessments have resulted in reduced hours of care for people with significant medical needs. Cleata* contacted our Economic Justice group after learning she would be losing the in-home medical assistance she depends on to live independently.

Attorney Trevor Townsend proved the nurse who assessed Cleata's needs failed to conduct a thorough and sound assessment and had mischaracterized Cleata's needs. Following a reassessment, Cleata's hours of care were restored.

MEDICAL-LEGAL PARTNERSHIPS

Our **Medical-Legal Partnerships (MLPs)** address **social determinants of health** related to housing, public benefits, family violence, and educational issues. Our MLPs are supported by an **integrated staffing model** in which all staff **collaborate and take responsibility** for every case. This **flexibility** allows us to best meet our **clients' unique needs** and ensure comprehensive care.

In 2025, we expanded our medical-legal partnerships to two new regional health centers and started a pilot program for our Beyond Opioids project.

PROJECTS


LOW-INCOME TAXPAYER CLINIC

Legal Aid's **Low Income Taxpayer Clinic (LITC)** plays a crucial role as a resource for low-income individuals. Our project serves as an **independent advocate** for taxpayers and provides **vital tax assistance** to Arkansans facing disputes with the **IRS and state tax agencies**. In partnership with the IRS Taxpayer Advocate Service, we support clients in resolving tax issues, including **audits, collections, appeals, and innocent spouse relief**. We also work to raise awareness and encourage the use of free **Volunteer Income Tax Assistance (VITA)** preparation services. Our goal is to combine **legal representation, community education, and policy advocacy** to ensure low-income taxpayers can effectively manage their interactions with tax authorities.

Service Highlights

- Our Low Income Taxpayer Clinic provided **402 tax consultations** in addition to formal legal representation.
- Our dedicated in-house **Spanish and Marshallese interpreters provided access for 271 tax clients**.

Outreach and Education

The **Low Income Taxpayer Clinic** reached **41,000 viewers** through its **educational programs on social media**. Our **"Tax 101" sessions** at **area high schools, NWA Community College**, and the **University of Arkansas** helped first-time filers navigate the federal tax system and **FAFSA applications**. Additionally, **Super Saturday VITA events** provided on-site tax rights education and **tax consultations**. Our collaborations with multiple community partners demonstrated our commitment that **tax justice** remains accessible to students, first-time filers, and families **across Arkansas**.

FAIR HOUSING PROJECT

Legal Aid's Fair Housing Project aims to provide housing opportunities for all Arkansans. Our efforts include **community education, public policy initiatives, and fair housing enforcement** through legal representation and testing.

As national enforcement priorities shifted and **funding** was delayed, our Fair Housing team focused on ensuring clients continued to receive guidance and representation. **Persistence and collaboration**, along with staff commitment, have sustained Legal Aid throughout this critical period. The year highlighted both the importance of fair housing protections and the **adaptability of the Legal Aid team** delivering them.

2025 Highlights

- Our Fair Housing Project closed **118 cases**, served a total of **283 household members**, including **77 children**, and helped our clients **avoid or recover \$67,095.***
- We conducted **95 fair housing tests** and trained **16 new testers**.
- We partnered with the **Arkansas Fair Housing Commission** on a **"Know Your Rights" tour** in **Southern Arkansas**.

VETERANS PROJECT

Legal Aid's Veterans Project helps Veterans overcome legal barriers that threaten their housing stability and overall well-being. We provide direct legal representation, participate in **Veterans Treatment Court**, and have a long-standing **Medical-Legal Partnership** with the **VA Medical Center in Fayetteville**.

In 2025, Legal Aid continued the partnership created between the Center for Arkansas Legal Services and the **VA Medical Center in Little Rock**.






Our **partnerships with treatment courts and VA medical centers** help us **reach more Veterans** and address a broader range of legal challenges, enabling us to efficiently and effectively meet the unique needs of our clients, regardless of their legal needs.

2025 Highlights

- Our Veterans Project closed **284 cases**, served a total of **570 household members**, including **157 children**, and helped our clients **avoid or recover \$855,890.***
- In 2025, our project significantly expanded its outreach to **women Veterans**, successfully increasing our reach within this demographic to **27%**.

PRO BONO

To ensure every Arkansan has access to civil legal services, Legal Aid of Arkansas depends on the **expertise of private practice attorneys** to bridge the gap between high demand and limited resources. Our **Pro Bono program** offers volunteers a rewarding opportunity to provide **life-changing representation** to clients who would otherwise go unrepresented. By donating their **time and skills**, volunteer attorneys not only enhance their professional reputations but also play a **critical role** in making **equal access to justice** a reality in Arkansas.

In 2025, our Pro Bono team broadened its reach by launching clinics in new counties. To manage this growth, we added a new staff member to support our expansion and volunteer coordination.

Pro Bono Highlights

- Our Pro Bono team held **42 clinics, serving 620 people** and providing **vital legal assistance** to **underserved communities**. Most clinics were **multidisciplinary**, focusing on a range of legal issues.
- In 2025, we had more than **190 volunteer attorneys and law student volunteers**, providing more than **1,950 volunteer hours, valued at more than \$280,300**.

Closing the Justice Gap

In 2025, Legal Aid of Arkansas significantly expanded its footprint to ensure **equal access to justice** reached every corner of the state. We held **17 rural clinics** in underserved communities, including **Salem, Yellville, and Jasper**, while maintaining large-scale operations in urban hubs such as **Little Rock and Fayetteville**.

As part of our **statewide transition**, we launched new clinics in **Texarkana, El Dorado, Pine Bluff, and Fort Smith**. Our **Road to Justice** tour reached **Heber Springs and Clinton**, while our **NYU partnership** provided specialized assistance in **West Memphis and DeWitt**, underscoring our **ongoing commitment to serving all Arkansans in their own communities**.

SOCIETY 6.1

Leadership in Service of Justice

In every generation, the **strength of our justice system has depended on lawyers willing to lead**. Society 6.1 is an opportunity to stand among them. On **December 5, 2025**, the Board of Directors of Legal Aid of Arkansas formally inaugurated **Society 6.1**, a statewide distinction reserved for attorneys whose leadership stands at the forefront of the **pursuit of civil justice**.

As attorneys, we have long understood that access to justice is not self-executing. Justice literally depends on the **leadership and commitment** of those admitted to the Bar. For years, attorneys in Pulaski County have demonstrated the value of strong leadership through VOCALS. **Society 6.1 is now building on that legacy and extending it across the state**, uniting attorneys who believe that justice should never depend on one's ability to afford counsel.

The name reflects **Rule 6.1 of the Arkansas Rules of Professional Conduct** — a reminder that service to those of limited means is not merely aspirational, but **integral to our profession**. Society 6.1 was created to support attorneys in **meeting their obligations** under Rule 6.1 while strengthening the partnership between the **private bar and civil legal aid**. And hopefully we will have a little fun along the way.

Membership

Attorneys in **good standing** are invited to join colleagues across Arkansas who are committed to preserving the **integrity of our courts** and ensuring that **civil legal services** remain accessible to all through:

- **6.1 hours of pro bono service** with Legal Aid in the prior year; or
- A **\$500 annual contribution** to Legal Aid of Arkansas and/or the Access to Justice Foundation; or
- a **combination of both**.

By recognizing these commitments, **Society 6.1** affirms that sustaining **access to justice** requires engagement at every level — **time, talent, and resources**. More than a giving society, Society 6.1 is a **circle of legal leaders**. Its members demonstrate that **professional excellence and public service** are not competing values, but inseparable ones. They understand that the strength of our civil justice system is measured not only by precedent and procedure, but by whether **ordinary Arkansans can meaningfully assert their rights**.

CASE HIGHLIGHT

Tenants Win \$10,300 Judgment: A Fight Against Unlivable Conditions

“I’ll just take everyone’s air conditioning unit this one time, minimizing the hassle, and the [tenants] can fry during the summer.... And I can take out the screen doors. Because they use the air conditioning and leave the door open with the screen closed to keep bugs and mosquitoes out. Let’s see how well those units breathe without screen doors—and with bugs flying in.”

This quote came from a March 2023 email from the owner of Greenbriar Apartments, as he explored ways to increase profits from his new HUD-subsidized rental property. Soon after, maintenance staff began **removing air conditioners**, telling tenants they would have to pay a substantial monthly surcharge to keep them. Management falsely claimed HUD had approved the new surcharge.

One resident, Yolanda, agreed to pay the surcharge. But her unit stopped working, and repair requests were ignored. That summer, Arkansas was experiencing a historic heatwave, putting residents’ health at risk as temperatures inside their homes **soared to over 90°F**. Yolanda made the heartbreaking decision to **break up her family**, sending her children to live with relatives for the summer to protect their health. Yolanda quit paying the surcharge, hoping to motivate them to make the repair. Instead, Greenbriar filed **eviction proceedings** for nonpayment of the surcharge. This is when she sought help from the Center for Arkansas Legal Services (CALs).

CALs attorneys, led by Kendall Lewellen, accepted the case on behalf of Yolanda and other residents. She secured a **Temporary Restraining Order** preventing further removal of air conditioners and alerted HUD to unsafe conditions, such as failure to properly maintain habitable housing. HUD later terminated its contract with Greenbriar and relocated tenants using Section 8 vouchers. **Legal Aid had begun hiring CALs staff in anticipation of the upcoming statewide transition**, and Kendall began working for Legal Aid. But this did not impact the lawsuit because Legal Aid and CALs worked hard to ensure **seamless care for all clients**.

The three-day jury trial was a **joint effort** between Legal Aid and CALs attorneys. The trial team was comprised of Kendall (from Legal Aid), Adrianna Hutson (from CALs), and the CALs Equal Justice Works Student-Fellow, Stephanie Wolfe-Wallace. The jury found Greenbriar had breached its tenants’ lease agreements and **awarded the clients \$10,300 in damages**, along with attorneys’ fees.*

*Greenbriar has appealed the decision. Kendall and Adrianna (who now also works for Legal Aid) are representing the tenants before the Arkansas Court of Appeals.

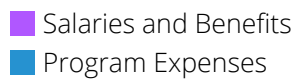
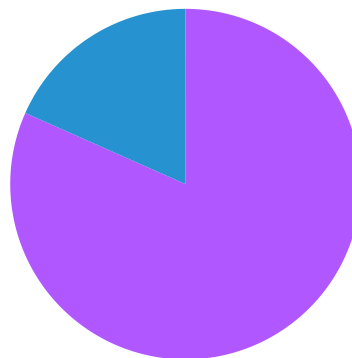
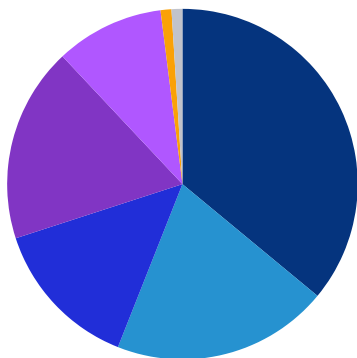
